FROM THE STATE HOUSE: LEGISLATIVE PRIORITIES

BODILY AUTONOMY: With partners, we defeated all 16 bills undermining trans rights and reproductive freedom - ranging from limits on adults' gender-affirming care to complete abortion bans. We also helped pass new laws to strengthen patient/provider privacy and expand access to family planning. PRIVACY: Big Tech pushed three bills to upend Maine's data privacy laws so companies could track what you do online and sell that data. We rallied a bi-partisan coalition to stop all of them.

VOTING RIGHTS: We helped defeat all bills targeting voting rights, including mandatory voter ID and ending ongoing absentee voting.

PUBLIC DEFENSE: We championed a bill to fund new public defenders, strengthening Maine's ability to uphold the right to a fair trial. This is another part of ending the public defense crisis, alongside our litigation in *Robbins v. Maine*.

IMMIGRANTS' RIGHTS & DUE PROCESS: As the federal government carries out a "mass deportation" agenda, we are fighting to protect due process rights and prevent Maine law enforcement from being complicit in federal civil rights abuses. We championed legislation to limit state and local police involvement in federal immigration enforcement. It passed both chambers and will become law unless the governor vetoes it at the start of the next session.

SEE YOU IN COURT: CASE HIGHLIGHTS

ROBBINS V. STATE OF MAINE:

ISSUE Maine is denying attorneys to people who have been charged with a crime and cannot afford their own, a clear violation of the Sixth Amendment.

STATUS Active: Maine appealed our trial court victory.

COURT Kennebec County Superior Court, Maine Supreme Judicial Court

STATE OF MAINE V. DERRIC MCLAIN:

ISSUE Police continued interrogating a suspect after he ambiguously invoked his right to remain silent, something police are allowed to do under the U.S. Supreme Court's interpretation of the Fourth Amendment. We urged the state court to expand protections at the state level, arguing that the Maine Constitution requires police to stop interrogations if a suspect invokes their right to remain silent or requests an attorney - even if they do so in an ambiguous manner.

STATUS Victory: The court ruled in our favor, expanding protections in Maine. **COURT** Maine Supreme Judicial Court (The ACLU of Maine presented arguments to the court as amicus to the case.)

SMITH V. TRUMP:

ISSUE Trump's sanctions against the International Criminal Court silence human rights advocates, violating their First Amendment rights.

STATUS The trial court blocked enforcement of the executive order as the case proceeds.

COURT U.S. District Court for the District of Maine

NHICS V. TRUMP and BARBARA V. TRUMP:


ISSUE Trump's executive order restricting birthright citizenship is a blatant violation of the 14th Amendment's plain language.

STATUS The trial court blocked enforcement of the executive order as the case proceeds. The federal government appealed, and the appeals court upheld our victory from the trial court.

COURT U.S. District Court for the District of New Hampshire, U.S. Court of Appeals for the First Circuit

THE YEAR **BY THE NUMBERS**

The ACLU of Maine Foundation and the ACLU of Maine (Union) are separate nonprofit organizations. The Foundation conducts litigation and public education programs. 
