Dear Sheriff Trundy,

I am writing to request some basic information about how your office and the Waldo County Correction Facility are working with ICE and CBP. Can you please send me the following information and documents:

- A copy of the current contract or any other document governing the relationship between the Waldo County Sheriff's Office, Waldo County Correction Facility, and ICE.

**We have no contracts or agreements with ICE**

- Is the Waldo County Correction Facility currently holding any ICE detainees? If yes, how many ICE detainees? Please also advise how we can receive regular information about the number and names of ICE detainees being held in the Waldo County Correction Facility.

**We are not holding anyone on ICE detainers. Although I do not currently have a mechanism in place to make public notifications regarding ICE detainees, I'd be happy to have the correctional administrator notify a contact at the ACLU. Please provide me with the name and contact information for your point of contact and I'll pass it along to my staff.**

- A copy of the contract or any other document governing the relationship between the Waldo County Sheriff's Office, Waldo County Correction Facility, and CBP.

**We have no contracts with CBP**

- Any policies or procedures related to holding individuals for CBP/ICE, including any policies or procedures related to ICE detainees.

We currently have no written policy governing ICE detainees. (we are currently developing a policy and expect to have it approved soon and I'd be happy to provide a copy once it has been finally approved.)

Please let me know if I should direct this request to someone else at Waldo County Correction Facility. Thank you for your time and assistance.
