Details: On 03/26/25 at approximately 23:07 hours I was on patrol in my assigned area. I observed a white GMC truck with PA-TR ZXN8452 traveling at a high rate of speed on US RT. 1 in Hancock. My radar clocked the vehicle going 70 MPH in a 50 MPH zone. I conducted a traffic stop with the vehicle and made contact with the male operator and the male passenger who were identified with their Russian identification cards. I went back to my vehicle and called the Houlton Barracks for the Border Patrol, I gave them the males' information and they stated they would have one of their agents call me.

A short while later I was contacted by Agent Mclellan from the Boarder Patrol, he requested I hold the two males there until his arrival. He arrived a short while later, after interviewing the males he took the driver of the truck into custody, the passenger was released from the scene, nothing further.
