I have completed a records check for Waldo County Sheriff's Office records regarding:

1. Incident reports detailing all traffic stops of individuals by the Waldo County Sheriff's Office from December 1<sup>st</sup>, 2024 to present in which the individual was taken into ICE or CBP custody.
2. All documentation associated with the above-referenced traffic stops.
3. From December 1<sup>st</sup>, 2024 to present, any communications between the Waldo County Sheriff's Office and ICE or CBP concerning the transportation of aliens.

I found one document that matches the search criteria and I have attached a publicly releasable copy that is redacted in accordance with Maine Title 16, Chapter 9, Section 804.



## Narrative

### Investigation Narrative

03/13/2025: At approximately 06:49 hours, I was conducting a radar detail on N Mountain Valley Hwy in Montville, ME. I was sitting stationary in drive way to Frye Mountain State Game Management. I observed a silver Toyota Carolla coming towards me at a visible high rate of speed. My radar unit displayed the vehicle was doing 65 MPH. The area we were in is a posted 50 MPH zone. The vehicle passed me continuing south bound.

I pulled out from where I was sitting and caught up to the vehicle, we were now just passed Bean Rd. I activated my emergency blue lights and conducted a traffic stop on the vehicle for it's speed. I observed the vehicle to be a silver Toyota Carolla with Maine transient plates [REDACTED]. I walked up to the vehicle and observed a [REDACTED] in the the drivers seat and [REDACTED] in the front passenger seat. I was able to later on identify the [REDACTED] as, [REDACTED] and the [REDACTED] as [REDACTED].

I explained to [REDACTED] the reason for the stop was due to [REDACTED] speed. [REDACTED] told me that [REDACTED] does not speak English. [REDACTED] and I communicated through a translation app on my department issued cell phone. I again explained the reason for the stop to [REDACTED] through the app and asked to see [REDACTED] license, insurance, and registration. [REDACTED] handed me a Florida license, the transient registration form, and advised me that [REDACTED] did not have active insurance. I went back to my patrol vehicle to run [REDACTED] and check [REDACTED] license status.

Dispatch informed me that [REDACTED] came back with an active license out of Florida but [REDACTED] Maine drivers license was suspended. Dispatch also informed me that [REDACTED] showed illegal immigration status and asked if I wanted them to confirm [REDACTED] through Border Patrol in Houlton, ME. I asked dispatch to do that and then went and made contact again with [REDACTED].

Again, through translation app on my phone, I explained to [REDACTED] that [REDACTED] license was suspended in Maine and [REDACTED] was not able to drive. I explained to [REDACTED] [REDACTED] would be getting a citation for operating after suspension and not having proof of insurance. I told [REDACTED] to work on getting a ride, while I finished up the paper work.

I finished the paperwork and then went to serve it to [REDACTED] asked if [REDACTED] could operate the motor vehicle. I asked if [REDACTED] had a valid license, [REDACTED] informed me that [REDACTED] had a Venezuela drivers license. I asked to see this license, [REDACTED] was able to provide the license to me. I went back to my patrol vehicle and ran [REDACTED] through dispatch. [REDACTED] came back with out a license.

Border Patrol Agent [REDACTED] called me and asked for the information of what I had going on. I explained to [REDACTED] what was going on, [REDACTED] advised me that [REDACTED] was legally allowed to be in the country but was not sure about [REDACTED]. I explained the Venezuela license that [REDACTED] provided to me to Agent [REDACTED]. [REDACTED] asked if [REDACTED] had any other documents showing [REDACTED] immigration status. I advised [REDACTED] I could go and ask [REDACTED]. I provided the information on the Venezuela license to Agent [REDACTED] so [REDACTED] could start checking [REDACTED] immigration status.

I went back to the vehicle and asked [REDACTED] if [REDACTED] had any other papers showing [REDACTED] immigration status. [REDACTED] handed me a passport with the country of origin being Venezuela. I took a photo of both the Venezuela license and passport and sent it to Agent [REDACTED]. [REDACTED] advised [REDACTED] that [REDACTED] was 6

minutes away. I served the citation to [REDACTED] and asked if [REDACTED] had any questions. The only question [REDACTED] had was where to take care of the suspension and I told [REDACTED] to contact the BMV. [REDACTED] signed the citation with out issue. I handed all paperwork back to [REDACTED] and advised [REDACTED] I would stay behind [REDACTED] until [REDACTED] uncle gets there.

I went back to my patrol vehicle and met with Deputy Potts while we waited. Agent [REDACTED] called me back and advised [REDACTED] was requesting a hold to be put on [REDACTED] as [REDACTED] believes [REDACTED] is here illegally and is coming to get [REDACTED]. [REDACTED] showed up to pick up [REDACTED]. I advised them that Border Patrol was on their way and we were waiting until they got here. While waiting, Agent [REDACTED] called and asked about immigration documents for [REDACTED]. I attempted to try and provide the information [REDACTED] was asking for by speaking with [REDACTED]. Agent [REDACTED] arrived on scene and took over.

Deputy Potts and I stood by for office safety. Agent [REDACTED] took [REDACTED] into custody as [REDACTED] determine they were not in the country legally. Deputy Potts gave [REDACTED] a ride back home to [REDACTED] residence in [REDACTED]. The vehicle was left on the side of the road, [REDACTED] was given 24 hours to get a licensed drive to go pick up the vehicle.

[REDACTED] was given a citation for operating after suspension and failure to provide proof of insurance.

Deputy Potts and I cleared the call. All body camera footage and cruiser camera footage has been uploaded into command central.

This ends my involvement in this matter.

On 03/14/2025 I over heard Dep. Masse on a traffic stop via radio whom was unable to verify identification on a passenger inside the vehicle. I responded and made contact with Dep. Masse who advised he was unable to identify the Passenger to attempt to find if the Passenger had a valid drivers license. Dep. Masse stated the current operator [REDACTED] was suspended in Maine but had a valid drivers license in Florida.

Dep. Masse contacted border patrol to verify a Venezuelan drivers license produced by the passenger [REDACTED] At the time neither [REDACTED] were able to speak english or understand and the conversation was had via google translate.

I stood by on the traffic stop while Border patrol responded and made contact with the driver and passenger. While speaking with both parties a licensed driver from Florida [REDACTED] whom was the [REDACTED] was founded to not have approved legal status in the United States. [REDACTED] was also founded to not have approved legal status in the United States. It was later founded both subjects were on pending legal status. Border Patrol Agent [REDACTED] took custody of both subjects.

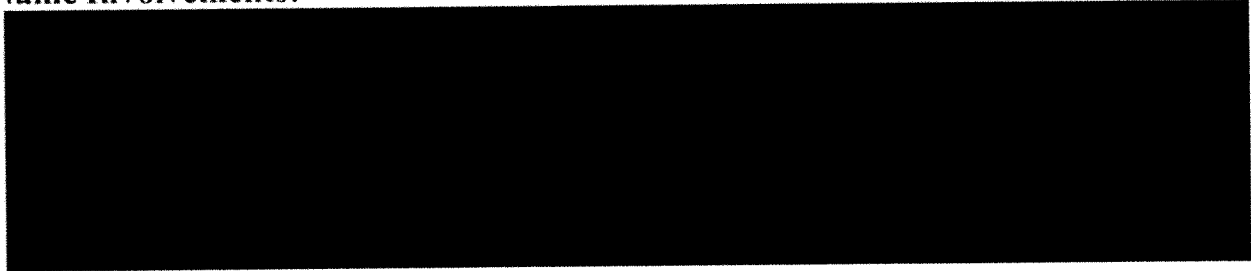
Due to [REDACTED] not having an active Maine License I gave him a ride home to [REDACTED]

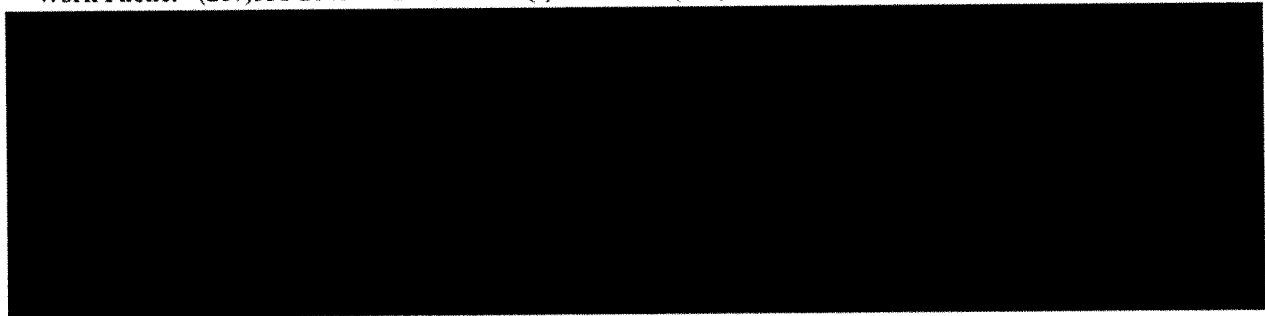
