

In order to better understand Maine's pretrial population, we requested information from each jail about how many people were booked into jail in 2017 and what offenses they were charged with. The amount and type of information we received varied by jail. Aroostook, Kennebec, Somerset and York County jails provided no information. The following is an analysis of the data we did receive, by jail.






# Androscoggin Jail Bookings 2017 - Top Ten Offenses






### Cumberland County Jail Bookings 2017 - Top Ten Offenses






## Oxford County Jail Bookings 2017 - Top Ten Offenses






## Penobscot County Jail Bookings 2017 - Top Ten Offenses






## Piscataquis County Jail Bookings 2017 - Top Ten Offenses



## Piscataquis County Jail Bookings 2017 - Top Ten Offenses as Percentage of Total Offenses




## Piscataquis County Jail Bookings 2017 - Top Ten Offenses as Percentages of Total Offenses (excluding warrants and holds)\*






## Waldo County Jail Bookings 2017 - Top Ten Offenses




