DEFENDANTS' MOTION TO DISMISS

Defendants in the above-captioned action (collectively "MCILS"), by and through undersigned counsel, pursuant to M. R. Civ. P. 12(b)(1) and (6), hereby move this Court to dismiss Plaintiffs' Complaint as follows:

I. INTRODUCTION

Plaintiffs' Complaint alleges that MCILS has failed to meet oversight standards, resulting in an indigent criminal defense system "that routinely and systematically denies indigent defendants their constitutional right to representation." Plaintiffs' Complaint at ¶7. "The constitutionally-guaranteed right of representation by counsel is a right of the highest order." State v. Watson, 2006 ME 80, ¶14 (quoting United States v. Proctor, 166 F.3d 396, 402 (1st Cir. 1999). However, unlike well-established claims seeking relief in criminal proceedings, "[t]here is no precedent from the United States Supreme Court acknowledging that a constructive denial of counsel claim may be brought in a civil case that seeks prospective relief in the form of more funding and resources to an entire office, as opposed to relief to individual indigent criminal defendants." Flora v. Luzerne Cty. of Com. of Pennsylvania, 103 A.3d 125, 136 (Pa. Commw.

Ct. 2014). Count I of Plaintiffs' Complaint fails to allege sufficient facts to meet any of the recognized standards for impugning Maine's compliance the Sixth Amendment and seeks unavailable relief. Count II of Plaintiffs' Complaint relies on inapplicable authority under Maine's Administrative Procedures Act. Plaintiffs' Complaint must, therefore, be dismissed.

II. STANDARD OF REVIEW

"A motion to dismiss tests the legal sufficiency of the complaint." *McAfee v. Cole*, 637 A.2d 463, 465 (Me.1994). "The general rule is that only the facts alleged in the complaint may be considered on a motion to dismiss and must be assumed as true." *Doe v. Bd. of Osteopathic Licensure*, 2020 ME 134, ¶ 3, 242 A.3d 182, 185 (quoting *Moody v. State Liquor & Lottery Comm'n*, 2004 ME 20, ¶ 8, 843 A.2d 43). While inferences to be drawn from pleadings are typically construed in favor of a plaintiff on a motion to dismiss, inferences in favor of plaintiff are not applied where a motion to dismiss challenges this Court's subject matter jurisdiction.

Davric Maine Corp. v. Bangor Historic Track, Inc., 2000 ME 102, ¶ 6, 751 A.2d 1024, 1028 ("[W]e do not make any favorable inferences in favor of [plaintiff] because the motion to dismiss is based on the subject matter jurisdiction of the court." (citing Hodgdon v. U.S., 919 F.Supp. 37, 38 (D.Me. 1996))).

The question controlling disposition of a motion to dismiss is whether the complaint, "sets forth elements of a cause of action or alleges facts that would entitle the plaintiff to relief pursuant to some legal theory." Ramsey v. Baxter Title Co., 2012 ME 113, ¶ 6 (citing McCormick v. Crane, 2012 ME 20, ¶ 5). Merely reciting the basic elements of a claim without underlying factual allegations is insufficient to meet this standard. Id. at ¶ 6 (quoting Bryan R. v. Watchtower Bible & Tract Soc'y of N.Y., Inc., 1999 ME 144, ¶ 22).

III. FACTS

Four of the five named Plaintiffs are allegedly incarcerated in Maine while awaiting trial. Plaintiffs' Complaint at $\P 11 - 15$. The fifth named Plaintiff, Brandy Grover, has allegedly plead guilty to a Class B felony and is currently incarcerated while awaiting sentencing. Id. at $\P 12$. All plaintiffs are allegedly Maine residents. Id. at $\P 11 - 15$.

All Plaintiffs were represented by counsel at all times from their initial appearances onward. Mr. Robbins, Mr. Peirce, and Ms. Grover assert that they were represented by a "lawyer of the day" at their initial appearances. Id. at ¶¶11-12, 14. Mr. Mack and Mr. Huynh, who do not specify whether they were represented by a "lawyer of the day" or their appointed counsel at their initial appearances, were represented by appointed counsel. Id. at ¶¶13, 15.¹

Mr. Mack and Mr. Huynh allege, with respect to the initial appearance at which each pled not guilty, that they "did not feel" that they had "sufficient information about" the charges, id. at ¶15, or the proceedings. Id. at ¶13.

While Mr. Robbins characterizes his contact with counsel as, "an approximately 30-second conversation at his door," id. at ¶11, Mr. Peirce and Mr. Mack allege "minimal contact" with their appointed defense counsel. Id. at ¶¶14 ("Mr. Peirce has had minimal contact—a handful of conversations each lasting only a few minutes—with his current state-appointed attorney."); id at ¶13 (since Mr. Mack's initial appearance, he "has had only minimal contact"

¹ This Court may take judicial notice of docket entries in the underlying criminal prosecutions to which Plaintiffs are parties. Cabral v. L'Heureux, 2017 ME 50, ¶ 10 ("Courts may take judicial notice of pleadings, dockets, and other court records where the existence or content of such records is germane to an issue in the same or separate proceedings." (citing Finn v. Lipman, 526 A.2d 1380, 1381 (Me. 1987); Union Mut. Fire Ins. Co. v. Town of Topsham, 441 A.2d 1012, 1016 (Me. 1982))). Docket records with respect to Mr. Mack (KENCD-CR-2021-00685) and Mr. Huynh (CUMCD-CR-2021-03436) indicate that both Plaintiffs were appointed counsel on the same date as the criminal complaint against each of them was filed. Copies of docket records for each Plaintiff are attached hereto for ease of reference.

with his attorney"). Ms. Grover alleges that she has "been unable to get in touch with her lawyer," since her guilty plea and prior to her upcoming sentencing. Id. at ¶12.

Mr. Peirce and Mr. Huynh allege that they have not received copies of discovery from their attorneys. Id. at $\P14-15$. Mr. Mack alleges that "his attorney has never taken the time to go through his discovery with him or discuss the [future] trial *in any detail*." Id. at 13 (emphasis added).

Finally, Ms. Grover and Mr. Peirce allege that they believe that their respective counsel were uninterested or hostile to their defense — without alleging any basis for that belief. Id. at ¶12 (Ms. Grover "believes that her lawyer was annoyed and angry at her for not taking a plea deal"); id. at ¶14 ("Their last phone call left Mr. Peirce with the impression that his attorney did not want Mr. Peirce to contact him").

IV. ARGUMENT AND MEMORANDUM OF LAW

Plaintiffs' Complaint fails to state a claim upon which relief can be granted on three grounds. First, Plaintiffs' Complaint does not allege: (1) circumstances constituting actual or constructive denial of counsel or (2) prejudice resulting from the alleged ineffectiveness of counsel previously recognized by Maine courts as necessary to support a claim of a Sixth Amendment violation. Without that threshold interest – standing – Plaintiffs' Complaint improperly seeks this Court's advisory opinion. See Plaintiffs' Complaint at ¶93.

Second, Plaintiffs' claims of a Sixth Amendment violation arising out of MCILS's alleged failure to "adequately fund" Maine's indigent criminal defense program states a non-cognizable claim and seeks to compel MCILS' compliance with a mandate to "fund" Maine's indigent criminal defense system which they are constitutionally unable to meet. Count I of Plaintiffs' Complaint therefore states a claim upon which relief cannot be granted.

Finally, Count II of Plaintiffs' Complaint, asserting that MCILS has failed to adopt statutorily mandated rules, fails based on Plaintiffs' failure to exhaust their administrative remedies and the fatal error of law underlying Plaintiffs' asserted cause of action.

A. Count I of Plaintiffs' Complaint fails to assert a justiciable controversy.

Plaintiffs are five (5) individuals seeking prospective declaratory and injunctive relief for themselves and members of a putative class. Plaintiffs assert a cause of action, pursuant to 14 U.S.C.A. § 1983, arising out of alleged systemic inadequacies of Maine's indigent criminal defense system, administered by MCILS. Plaintiffs allege that those inadequacies violate their rights under the Sixth Amendment of the United States Constitution. Plaintiffs seek declaratory and injunctive relief against MCILS.

Pursuant to the Maine Constitution, judicial power extends to justiciable controversies.

Flaherty v. Muther, 2011 ME 32, ¶ 87, 17 A.3d 640, 662 (citing Connors v. Int'l Harvester

Credit Corp., 447 A.2d 822, 824 (Me.1982)). "A decision issued on a non-justiciable

controversy is an advisory opinion, which we have no authority to render except on solemn

occasions, as provided by the Maine Constitution." Id. The Law Court has held:

Justiciability requires a real and substantial controversy, admitting of specific relief through a judgment of conclusive character. A justiciable controversy involves a claim of present and fixed rights based upon an existing state of facts. Accordingly, rights must be declared upon the existing state of facts and not upon a state of facts that may or may not arise in the future.

Madore v. Maine Land Use Regul. Comm'n, 1998 ME 178, ¶7, 715 A.2d 157, 160 (citing Halfway House, Inc. v. City of Portland, 670 A.2d 1377, 1379 (Me.1996); Campaign for Sensible Transp. v. Maine Turnpike Auth., 658 A.2d 213, 215 (Me.1995)) (internal citations and quotations omitted). Justiciability requires that the parties asserting the claim have standing, "the absence of which impairs the subject matter jurisdiction of the court." Smith v. Allstate Ins. Co.,

483 A.2d 344, 346 (Me. 1984) (citing 2 Field, McKusick & Wroth, Maine Civil Practice § 57.1 at 361 & n.18.30 (2d ed. Supp.1981)); see also Mason v. City of Augusta, 2007 ME 101, ¶ 15, 927 A.2d 1146, 1150 ("A court lacks subject matter jurisdiction when the case is of a type that falls outside a court's adjudicatory authority." (citing Landmark Realty v. Leasure, 2004 ME 85, ¶ 7)). "A plaintiff's lack of standing renders that plaintiff's complaint nonjusticiable—i.e., incapable of judicial resolution." Bank of Am., N.A. v. Greenleaf, 2015 ME 127, ¶ 8, 124 A.3d 1122, 1125 (citing Homeward Residential, Inc. v. Gregor, 2015 ME 108, ¶ 19, 122 A.3d 947)

A plaintiff seeking prospective injunctive relief must allege a "particularized injury." Matter of Int'l Paper Co., Androscoggin Mill Expansion, 363 A.2d 235, 239 (Me. 1976); see also Fitzgerald v. Baxter State Park Auth., 385 A.2d 189, 197 (Me. 1978); Madore, 1998 ME 178 at ¶ 13 ("to have standing to seek injunctive and declaratory relief, a party must show that the challenged action constitutes 'an invasion of a legally protected interest which is (a) concrete and particularized, and (b) actual or imminent, not conjectural or hypothetical." (quoting Lujan v. Defenders of Wildlife, 504 U.S. 555, 560 (1992))). Likewise, the Declaratory Judgments Act, "does not establish a subject-matter jurisdiction by which the Superior Court achieves power to act." Desmond v. Persina, 381 A.2d 633, 638 (Me. 1978) (citing Walsh v. City of Brewer, 315 A.2d 200, 210 (Me. 1974)). "[T]o invoke the aid of the courts under the Declaratory Judgments Act, the [plaintiff] must demonstrate the existence of a justiciable controversy." Id. at 638; see also Maine Tpk. Auth. v. Brennan, 342 A.2d 719, 723 (Me. 1975) ("Although the Declaratory Judgment Act expands the range of available relief, it does not relax the requirements of justiciability necessary to present the court with a judicable controversy."); Berry v. Daigle, 322 A.2d 320, 326 (Me. 1974) ("The Declaratory Judgments Act does not create a new cause of action; it merely authorizes a new form of relief.").

Maine courts have, applying longstanding precedent, recognized causes of action for violation of the Sixth Amendment in the context of post-conviction relief. Plaintiffs alleging that they were denied the assistance of counsel must meet well-established burdens to establish their standing. For reasons known only to Plaintiffs, Plaintiffs decline to allege that their recited interactions with appointed defense counsel caused them prejudice. The result is two unconnected sets of allegations. The first set asserts Plaintiffs' concerns about the frequency of contact with their respective MCILS appointed counsel and subjective opinions about their attorneys' views of the merits of Plaintiffs' defenses to pending criminal charges, without alleging or providing context supporting (or allowing an objective evaluation of) prejudice. The second set alleges that practices of MCILS could lead to Sixth Amendment violations. The missing connection between those sets of allegations is fatal to Plaintiffs standing and Count I of Plaintiffs' Complaint.

The current procedural posture, forecloses MCILS from rebutting Plaintiffs' contentions about their interactions with individual defense counsel. See Doe, 2020 ME 134 at ¶ 3 ("[O]nly the facts alleged in the complaint may be considered on a motion to dismiss and must be assumed as true."). However, that standard does not allow this Court to infer a causal connection which Plaintiffs fail to allege. See, e.g., Gagliardi v. Sullivan, 513 F.3d 301, 307 (1st Cir. 2008) (affirming dismissal of claim for failure to allege that defendants caused alleged violation of Plaintiffs' First and Fourteenth Amendment rights); Wang Yan v. ReWalk Robotics Ltd., 330 F. Supp. 3d 555, 560 (D. Mass. 2018) (dismissing claim requiring proof of a "false or misleading statement" because Plaintiffs did not allege such a statement). Merely reciting the basic elements of a claim without supporting factual allegations is insufficient to survive a motion to dismiss. Ramsey, 2012 ME 113 at ¶ 6 (quoting Bryan R., 1999 ME 144 at ¶ 22).

Maine courts have not recognized the cause of action asserted in Count I of Plaintiffs' Complaint: that Maine's indigent defense *system* fails to comply with Maine's obligations under the Sixth Amendment. There are three (3) recognized standards applicable to Sixth Amendment claims, each of which establishes a distinct burden. Plaintiffs' allegations fail to meet any of those standards.

1. Plaintiffs' Complaint does not allege facts sufficient to meet the standards Maine courts apply to claims of Sixth Amendment violations

The Sixth Amendment requires that states provide counsel to criminal defendants charged with crimes which could, upon conviction, result in imprisonment. Lagassee v. State, 655 A.2d 328, 329 (Me. 1995) (Sixth Amendment "guarantee[s] a criminal defendant's right to effective assistance of counsel.") (citing Tribou v. State, 552 A.2d 1262, 1264 (Me.1989)). "For those who cannot afford counsel, the constitutional right imposes an affirmative obligation on the State to provide court-appointed counsel if the defendant faces incarceration whether because of a plea of guilty or no contest, or after trial." Watson, 2006 ME 80 at ¶ 14 (collecting cases); see also M. R. U. Crim. P. 44(a).

a. Plaintiffs' Complaint does not allege prejudice, required to meet the Strickland test.

"Strickland [v. Washington, 466 U.S. 668, 104 S.Ct. 2052 (1984)] is the 'seminal case' that establishes the standards controlling the disposition of claims of ineffective assistance of counsel." Theriault v. State, 2015 ME 137, ¶ 13 (citing Manley v. State, 2015 ME 117, ¶ 12, 123 A.3d 219). Under Strickland, a plaintiff must "show both that counsel's representation fell below an objective standard of reasonableness and that there exists a reasonable probability that, but for counsel's unprofessional errors, the result of the proceeding would have been different."

Kimmelman v. Morrison, 477 U.S. 365, 375, 106 S. Ct. 2574, 2582–83, 91 L. Ed. 2d 305 (1986) (citing Strickland, 466 U.S., at 688) (internal citations omitted); see also Laferriere v. State, 1997 ME 169, ¶ 6 ("The inquiry is: '(1) whether counsel's performance falls measurably below the performance that might be expected of an ordinary, fallible attorney; and, if so, (2) whether counsel's substandard performance likely deprived the defendant of an otherwise available substantial ground of defense.' (quoting Lagassee, 655 A.2d at 329)).

Plaintiffs allege no conduct by their attorneys which "falls measurably below the performance that might be expected of an ordinary, fallible attorney." *Laferriere*, 1997 ME 169 at ¶ 6. Likewise, neither Ms. Grover, who alleges she has plead guilty and is incarcerated while awaiting sentencing, or the four (4) Plaintiffs incarcerated while awaiting trial, allege deprivation of "an otherwise available substantial ground of defense." *Id.* Plaintiffs' allegations amount to nothing more than Plaintiffs' statements that they could not reach their attorneys as quickly or frequently as they would like and, in the cases of Mr. Huynh and Mr. Mack, assertions that they do not understand the charges against them or the substance of discovery provided to their attorneys to the degree they would like. Plaintiffs' Complaint at ¶¶13, 15. These allegations are insufficient to meet the *Strickland* test. *Cf. Lagassee*, 655 A.2d at 330 ("trial attorney's failure to obtain [exculpatory] medical record falls measurably below the performance of an ordinary, fallible attorney, and [] likely deprived [plaintiff] of an otherwise available substantial ground of defense.").

Plaintiffs' recitation of the potential consequences of alleged faults in MCILS' administration of Maine's indigent criminal defense system adds nothing to address the Strickland test. See, e.g. United States v. Snyder, 184 F. App'x 356, 359 (4th Cir. 2006) (rejecting ineffective assistance claim where plaintiff was "unable to prove any actual prejudice and only

claims [] potential prejudice"); State v. Raver, 2003-Ohio-958, ¶ 67 (distinguishing between acknowledged "potential" risk from trying criminal cases together and showing of "actual" prejudice); Bonin v. Calderon, 59 F.3d 815, 827 (9th Cir. 1995) (distinguishing between "actual" and "potential" conflict of interest). Plaintiffs' Complaint does not allege circumstances meeting the Strickland standard.

b. Plaintiffs' Complaint does not allege circumstances justifying a presumption of prejudice under *Cronic*.

Recently describing the United States Supreme Court's holding in *United States v.*Cronic, 466 U.S. 648, 659-60 (1984), the Law Court observed:

In *Cronic*, the Court identified three specific circumstances that warranted the presumption. The first and most obvious is a complete denial of counsel at a critical stage. The second occurs if counsel entirely fails to subject the prosecution's case to meaningful adversarial testing. And, the third occurs when the circumstances are such that even a fully competent attorney, could not provide effective assistance of counsel."

In re Child. of Kacee S., 2021 ME 36, ¶30 n.7 (quoting Fusi v. O'Brien, 621 F.3d 1, 7 (1st Cir. 2010)). "In cases where counsel's ineffectiveness amounts to the 'constructive denial of the assistance of counsel,' prejudice is 'legally presumed' and need not be affirmatively proved." Theriault, 2015 ME 137 at ¶17 (citing Strickland, 466 U.S. at 692 and Cronic, 466 U.S. at 659). However, the presumption of constructive denial of the assistance of counsel "can be applied only when defense counsel utterly fails in defending a client." Pineo v. State, 2006 ME 119, ¶15, 908 A.2d 632, 639. "Such cases, however, are 'rare,' and occur when there is a "complete denial of counsel" or when "counsel entirely fails to subject the prosecution's case to meaningful adversarial testing." Theriault, 2015 ME 137 at ¶17 (quoting Laferriere, 1997 ME 169 at ¶11 and Cronic, 466 U.S. at 659).

Plaintiffs' Complaint cites, but fails to allege facts implicating, *Cronic*, 466 U.S. at 659-60. Plaintiffs' Complaint at ¶2 ("The government must provide *effective* counsel to indigent defendants under circumstances that allow for competent and meaningful representation.") (emphasis in original). All Plaintiffs have been represented by counsel from their initial appearance onward. Plaintiffs do not allege facts supporting a conclusion that their respective counsel "entirely fail[ed]" to meaningfully test the prosecution's case against them. Plaintiffs' Complaint at ¶11 – 15. Plaintiffs' Complaint likewise fails to allege any facts which would meet the third option under *Cronic*: circumstances in which no competent attorney could provide effective assistance, and therefore justifying a presumption of prejudice. *See, e.g. Laferriere*, 1997 ME 169 at ¶11 (collecting cases reflecting, *inter alia*, denial of counsel at preliminary hearing, denial of counsel at arraignment, requirement that defendant testify as first defense witness, and "bar on direct examination of defendant"). Accordingly, Plaintiffs' Complaint fails to allege circumstances meeting the *Cronic* test.

c. Plaintiffs' Complaint does not allege denial of counsel, required to implicate *Gideon*.

Plaintiffs cite *Gideon v. Wainwright*, 372 U.S. 335, 344 (1963) but fail to allege facts implicating the right to appointment of counsel announced in *Gideon*. Plaintiffs' Complaint at ¶1 ("it is the state's responsibility to ensure that 'any person haled into court, who is too poor to hire a lawyer,' is provided with an adequate legal defense."). Plaintiffs do not allege that they were actually denied counsel at any stage of their criminal cases. *Cf. Tucker v. State*, 394 P.3d 54, 63 (Idaho 2017) (finding standing among Plaintiffs challenging Idaho's public defense system where Plaintiffs, "were not represented by counsel at their initial appearances.") and *Hurrell-Harring v. State*, 15 N.Y.3d 8, 22, 930 N.E.2d 217 (2010) (plaintiffs' complaint alleging

systemic Sixth Amendment violations implicated *Gideon* because it, "contains numerous plain allegations that in specific cases counsel simply was not provided at critical stages of the proceedings."). In fact, Maine's criminal rules require, "[w]hen a person is entitled to court appointed counsel," that counsel be appointed "not later than the time of the initial appearance." M. R. U. Crim. P. 5(e). Consistent with that obligation, Plaintiffs were represented by counsel at all stages of their criminal matters from their initial appearances forward. Plaintiffs' Complaint at ¶11 – 15.

2. Plaintiffs' Complaint does not allege a justiciable controversy.

Plaintiffs' Complaint alleges that Maine has violated the constitutional right to counsel guaranteed by the Sixth Amendment. However, Plaintiffs' Complaint fails to allege facts sufficient to justify a finding that the named Plaintiffs have standing to pursue those claims under the new cause of action Plaintiffs propose. See, e.g., Kuren v. Luzerne Cty., 146 A.3d 715 (2016) ("We recognize for the first time in Pennsylvania a prospective cause of action enabling indigent criminal defendants to prove that the level of funding provided by a county to operate a public defender's office has left that office incapable of complying with Gideon, creating the likelihood of a systematic, widespread constructive denial of counsel in contravention of the Sixth Amendment to the United States Constitution."). Plaintiffs, accordingly, lack the necessary procedural "vehicle" to invoke this Court's power to adjudicate the question presented in Count I of Plaintiffs' Complaint. See Dep't of Corr. v. Superior Ct., 622 A.2d 1131, 1135 (Me. 1993) (recognizing court's competence to "protect the individual from an unconstitutional invasion of his rights by the legislative [or executive] branch[es] of government" subject to requirement that "the power of courts must be invoked by appropriate process."). Plaintiffs' Complaint fails to allege facts which would support a finding of harm sufficient to violate the Sixth Amendment

under any test recognized by Maine courts. Plaintiffs therefore lack standing to compel this Court to adjudicate the questions presented in Count I of Plaintiffs' Complaint. Count I of Plaintiffs' Complaint must, therefore, be dismissed.

B. Count I of Plaintiffs' Complaint fails to assert a claim upon which relief can be granted.

Plaintiffs claim that MCILS's alleged failure to "fund" Maine's indigent defense system violates the Sixth Amendment and seek prospective injunctive relief to remedy that alleged constitutional violation. MCILS is not empowered to fund Maine's indigent defense system. 5 M.R.S.A. § 1543 ("Money may not be drawn from the State Treasury except in accordance with appropriations duly authorized by law."); see also OPEGA Report (Plaintiffs' Complaint, Exhibit 2) at p. 36 (noting "[t]he Legislature appropriated approximately \$17.7 million for MCILS in FY20, and \$17.6 for FY21."). "[T]he unavailability of a remedy is a sufficient ground for a motion to dismiss for failure to state a claim." Doe, 242 A.3d 182 at ¶22 (citing D & J Assocs. v. Bd. of Env't Prot., 560 A.2d 4, 4 (Me. 1989)). To the extent Plaintiffs' Complaint states a claim upon which relief cannot be granted and it must, therefore, be dismissed.

1. MCILS does not "fund" Maine's indigent criminal defense system.

Plaintiffs Complaint asserts that MCILS created a substantial risk of Sixth Amendment violations by failing to "fund" Maine's indigent defense system. Plaintiffs' Complaint at ¶3 ("MCILS has failed in its constitutional and statutory obligation to . . . fund a system that provides effective representation to indigent defendants"), ¶16 (alleging MCILS is obligated to "ensure adequate funding of a statewide system of indigent legal services" (citing 4 M.R.S.A. § 1801)); ¶93(ii) (asserting common question of law among proposed class members

of, "[w]hether Defendants' failure to adequately fund the delivery of indigent defense services, and, in particular, to ensure that attorneys are appropriately compensated, results in the provision of constitutionally deficient representation."); ¶94 (alleging ongoing harm resulting from, "MCILS's ongoing failure to adequately supervise, administer, and fund indigent-defense services."); ¶102 ("MCILS has failed to adequately supervise, administer, and fund an indigent defense system, thereby violating the rights of poor defendants across the State."); ¶110 ("In particular, MCILS has failed to . . . ensure adequate funding and support for rostered attorneys"). Consistent with the constitutional roles of the parties which Plaintiffs chose to identify as defendants in this action and seek to enjoin, however, Plaintiffs assiduously omit any reference to "funding" in their request for relief. Cf. Plaintiffs' Complaint at ¶3 ("This lawsuit challenges the failure of [MCILS] to adequately supervise, administer, and fund an indigent defense system") (emphasis added) and id, at ¶II (seeking "[i]njunctive relief requiring Defendants to guarantee the assistance of counsel to Plaintiffs and those similarly situated by establishing adequate gatekeeping, supervision, and training of state-appointed counsel ") (emphasis added). However, Plaintiffs' contention that MCILS' alleged failure to "adequately fund" Maine's indigent criminal defense system violates Plaintiffs' Sixth Amendment right to assistance of counsel and request that the Court enjoin MCILS to "guarantee the assistance of counsel" necessarily seeks funding. Plaintiffs' Complaint at ¶110.2

In order to fund the programs it administers, MCILS is directed to "[a]pprove and submit a biennial budget request to the Department of Administrative and Financial Services, Bureau of

² To the extent Plaintiffs' Complaint contends that the "inadequacy" of funding underlying the claims in Count I of Plaintiffs' Complaint arises out of decisions made by MCILS, a request to judicially review the manner in which funds allocated by the Legislature are disbursed does not create a justiciable issue. The Law Court has held that requests to the judiciary to "address the internal funding and administrative decisions" of the executive branch "cannot be adjudicated because they are quintessentially nonjusticiable." *Maine Senate v. Sec'y of State*, 2018 ME 52, ¶34, 183 A.3d 749, 759 (addressing question raised by Plaintiff regarding whether Secretary of State's allocation of funds violated "appropriation for the Secretary of State in the biennial budget law.").

the Budget, including supplemental budget requests as necessary." 4 M.R.S.A. § 1804(3)(I); see also 4 M.R.S.A. § 1805(7)(A) (providing that MCILS' Executive Director shall "[p]repare and submit to the commission . . . a proposed biennial budget for the provision of indigent legal services, including supplemental budget requests as necessary."). MCILS is likewise directed to annually "submit to the Legislature, the Chief Justice of the Supreme Judicial Court and the Governor an annual report on the operation, needs and costs of the indigent legal services system . . . The joint standing committee of the Legislature having jurisdiction over judiciary matters may report out legislation on matters related to the report." 4 M.R.S.A. § 1804(3)(H); Cf. Sixth Amendment Center, The Right to Counsel in Maine: Evaluation of Services Provided by the Maine Commission on Indigent Legal Services (Plaintiff's Complaint, Exhibit 1). Similarly, the Executive Director of MCILS is authorized to "Receiv[e] from the courts collections for the costs of representation from defendants or civil parties who are found to be partially indigent or

³ MCILS Executive Director Memorandum (Dec. 23, 2021) (Plaintiffs' Complaint, Exhibit 4), p.7 ("The Commission receives insufficient support for necessary operations. MCILS expects to be able to meet its current and projected operational expenses for the FY22-23 biennium with current funding. To meet some of goals set for MCILS, however, additional funding and headcount will be necessary."); id. at p. 11 ("The Legislature did not fund the initiation of any statewide or local public defender offices. [] MCILS expects to renew its request for employed counsel for the next biennial budget."); MCILS Executive Director Memorandum (Jan. 7, 2021), p.2 ("To solve these [funding] issues, MCILS funding should be statutorily defined based on a state-wide per-capita funding level consistent with an adequate defense function and revised based on changes to the state-wide cost of business. MCILS should maintain a non-lapsing account with trust-like rules to address fluctuations in costs. The account could be initially funded with a small fraction of the current surplus. Operational savings would be deposited to the account, and unusual operating costs could be debited from the account."); id. at p.3 ("Through its initiatives request in late 2020, and through testimony to legislative committees in early 2021, MCILS asked that it be funded for "pilot" defender programs."); id. at 7 ("MCILS attorneys are diligent, conscientious, believers injustice. They are. however, not adequately recognized and represented in government. MCILS must be funded and authorized to fulfill that function."); id. at 8 ("Compliance with a constitutionally sound supervision structure will require the addition of many field training and supervision staff. MCILS should be authorized and funded to employ that staff."). 4 Id. at p.IX (recommending, "[t]he State of Maine should fund MCILS at a level to ensure rigorous training and effective substantive and financial oversight of attorneys."); id. at p.X ("The State of Maine should fund MCILS at a level that allows private attorneys to be compensated for overhead expenses plus a reasonable fee (i.e., \$100 per hour),"; id. ("The State of Maine should authorize and fund MCILS at an appropriate level to employ state government attorneys and support staff to operate a statewide appellate defender office."), id. at p.9 (noting occasion when "the approved [attorney reimbursement] vouchers accumulated pending an appropriation and then later were approved simultaneously when the funds became available [to MCILS].").

who have otherwise been determined to be able to reimburse the commission for expenses incurred by assigned counsel or contract counsel." 4 M.R.S.A. § 1805-A(1)(E).

Count I of Plaintiffs' Complaint alleges that MCILS violated the Sixth Amendment by failing to "adequately fund" Maine's indigent criminal defense system. MCILS is not empowered to "fund" Maine's indigent criminal defense system. Consistent with Maine's constitutional separation of powers, appropriations come from the legislative branch. 5 M.R.S.A. § 1543; see also L.D. 2126, 129th Leg., 2 d Reg. Sess. (Me. 2020) (appropriating "additional funding for indigent legal services"). Accordingly, MCILS' alleged failure to "fund" that system does not state a cognizable claim and Count I of Plaintiffs' Complaint must be dismissed.

2. The separation of powers in the Maine Constitution prevents this Court from compelling the appropriation of funds for Maine's indigent criminal defense system.

While not expressly enumerated among the items of relief sought in Plaintiffs' Complaint, Plaintiffs allegation a lack of "adequate funding" denies Plaintiffs' Sixth Amendment right to the assistance of counsel, Plaintiffs' Complaint at ¶¶3, 16, 93(ii), 94, 102, 110, and demand an injunction ordering MCILS to "guarantee the assistance of counsel to Plaintiffs and those similarly situated," impliedly demands funding. Id. at ¶II. "The Maine Constitution [] bars Maine courts' exercise of executive or legislative power, and we have held that the separation is 'much more rigorous' than the bar imposed by the United States Constitution upon the federal courts' exercise of nonjudicial power." Burr v. Dept. of Corr., 220 ME 130, ¶20 (citing Bates v. Dept. of Behav. & Dev. Svcs., 2004 ME 154, ¶84); see also Maine Equal Just. Partners v.

⁵ The appropriation, available at https://legislature.maine.gov/legis/bills/getPDF.asp?paper=HP1516&item=5&snum=129, appears at Section A-8 (p.21) and authorizes a resulting disbursement of funds by the treasurer at Section CC-1 (p.42-43).

Comm'r, Dep't of Health & Hum. Servs., 2018 ME 127, ¶ 39 (Alexander, J., dissenting) ("Court involvement in ordering funding for statutorily authorized programs, when appropriations to support such programs fail or are viewed as inadequate to meet perceived needs, would violate Maine's strict separation of powers requirements as stated in article III of the Maine Constitution (Distribution of Powers)."). "The Legislature of Maine may enact any law of any character or on any subject, unless it is prohibited, either in express terms or by necessary implication, by the Constitution of the United States or the Constitution of this State." SC Testing Tech., Inc. v. Dep't of Env't Prot., 688 A.2d 421, 424 (Me. 1996) (quoting League of Women Voters v. Secretary of State, 683 A.2d 769, 771 (Me.1996)); see also Sawyer v. Gilmore, 109 Me. 169, 83 A. 673, 678 (1912) ("The powers of the Legislature in matters of legislation, broadly speaking, are absolute, except as restricted and limited by the Constitution. As to the executive and judiciary, the Constitution measures the extent of their authority, as to the Legislature it measures the limitations upon its authority.").

This court cannot compel the appropriation of funds for indigent criminal defense.

Therefore, Plaintiffs' request for prospective injunctive relief to remedy that alleged lack of funding states a claim upon which relief cannot be granted.

C. PLAINTIFFS FAIL TO STATE A COGNIZABLE CLAIM THAT MCILS IS OBLIGATED TO ADOPT THE RULES WHICH PLAINTIFFS ALLEGE.

Plaintiffs' Complaint asserts that MCILS has failed to adopt rules as required by 4 M.R.S.A. § 1804. Plaintiffs' Complaint at ¶¶119-122 (citing 4 M.R.S.A. § 1804(2)). Section 1804 directs MCILS to adopt various "standards." Id.⁶ Plaintiffs also allege that MCILS has

⁶ 2. Standards. The commission shall develop standards governing the delivery of indigent legal services, including:

failed to comply with a statutory obligation to, "[e]stablish *procedures* for handling complaints about the performance of counsel providing indigent legal services." 4 M.R.S.A. § 1804(3)(M) (emphasis added).

Plaintiffs assert that they are entitled to "[j]udicial review of . . . an agency's refusal or failure to adopt a rule where the adoption of a rule is required by law" 5 M.R.S.A. § 8058(1). Plaintiffs also assert that they are entitled to judicial review of MCILS' alleged failure to comply with Section 1804 under the Maine Administrative Procedures Act ("APA"). Plaintiffs' Complaint at ¶ 117 (citing 5 M.R.S.A. § 11001(2)).

1. Section 1804 does not mandate that MCILS adopt rules.

As defined in the APA, "'Rule' means the whole or any part of every regulation, standard, code, statement of policy, or other agency guideline or statement of general applicability, including the amendment, suspension or repeal of any prior rule, that is or is intended to be judicially enforceable and implements, interprets or makes specific the law administered by the agency, or describes the procedures or practices of the agency." 5 M.R.S.A. § 8002(9)(A). A "rule" expressly does not include, "[p]olicies or memoranda concerning only

A. Standards governing eligibility for indigent legal services. The eligibility standards must take into account the possibility of a defendant's or civil party's ability to make periodic installment payments toward counsel fees;

B. Standards prescribing minimum experience, training and other qualifications for contract counsel and assigned counsel:

C. Standards for assigned counsel and contract counsel case loads;

D. Standards for the evaluation of assigned counsel and contract counsel. The commission shall review the standards developed pursuant to this paragraph every 5 years or upon the earlier recommendation of the executive director:

E. Standards for independent, quality and efficient representation of clients whose cases present conflicts of interest:

F. Standards for the reimbursement of expenses incurred by assigned counsel and contract counsel; and

G. Other standards considered necessary and appropriate to ensure the delivery of adequate indigent legal services.

Id. (emphasis added).

the internal management of an agency or the State Government and not judicially enforceable." 5 M.R.S.A. § 8002(9)(B)(1).

The "standards" addressed in Section 1804 are not "rules". See DownEast Energy Corp. v. Fund Ins. Rev. Bd., 2000 ME 151, ¶ 23 ("An agency may [] provide guidance for its employees and the public without adopting the guiding materials as rules" (citing York Mut. Ins. Co. of Me. v. Superintendent of Ins., 485 A.2d 239, 242 (Me. 1984))). MCILS' alleged failure to adopt standards or procedures is, therefore, not susceptible to challenge pursuant to 5 M.R.S.A. § 8058. Plaintiffs' contention that "MCILS must adopt rules to ensure that the provision of representation complies with constitutional standards," is not based on any statutory authority. Plaintiffs' Complaint at ¶ 122; see also 5 M.R.S.A. § 8055(1) ("Any person may petition an agency for the adoption or modification of any rule."). Count II of Plaintiffs' Complaint must be dismissed.

2. Plaintiffs are not entitled to review pursuant to 5 M.R.S.A. § 11001(2).

Section 11001 allows review: of an agency's "failure or refusal" to act by a person "aggrieved" thereby. 5 M.R.S.A. § 11001(2). "A person is aggrieved within the meaning of the APA if that person has suffered particularized injury—that is, if the agency action operated prejudicially and directly upon the party's property, pecuniary or personal rights. *Nelson v. Bayroot, LLC*, 2008 ME 91, ¶ 10, 953 A.2d 378, 382 (citing *Storer v. Dep't of Envtl. Prot.*, 656 A.2d 1191, 1192 (Me.1995); *Hammond Lumber Co. v. Fin. Auth. of Me.*, 521 A.2d 283, 286 (Me.1987)). Plaintiffs Complaint fails to assert any particularized injury arising out of MCILS' alleged failure to adopt the standards enumerated in Section 1804. Plaintiffs are, accordingly, not "aggrieved" by MCILS' alleged failure to adopt the standards or procedures.

A petition under Section 11001(2) must be filed, "within 6 months of the expiration of

the time within which the action should reasonably have occurred." 5 M.R.S.A. § 11002(3). A

claim that an agency should reasonably have acted requires the petitioner to establish prejudice

from the alleged failure. Doe, 2020 ME 134, ¶26 ("We conclude that a showing of prejudice is

required to succeed in a claim for failure to act under the APA."). Similar to Plaintiffs' failure to

allege any basis to conclude they were "aggrieved" by MCILS' alleged failure to adopt standards

under Section 1804, Plaintiffs' Complaint likewise fails to assert any basis for a conclusion that

they have been "prejudiced" by MCILS' alleged failure to adopt those standards. Count II of

Plaintiffs' Complaint must be dismissed.

WHEREFORE Defendants pray this Court grant their Motion to Dismiss, Dismiss Plaintiffs'

Complaint, and grant all such other and further relief as this Court deems just.
